- A. Call to Order Rollcall
  - a. The meeting was called to order at 10:05 am by Tiera Hawkes (Chair).
  - b. Roll call and introductions.

- B. Review and Approval of Agenda
  - a. David Cramer moved to approve the April 12, 2024 Agenda. The Agenda was approved without objections.
- C. Review and Approval of Minutes
  - a. David Cramer moved to approve the March 28, 2024 minutes.
- D. Staff Report
  - a. Chief Lisa Kelly spoke about the PIB staffing shortage.
    - i. ACC case managers can pull discipline and provide it to the ACC.
    - ii. Supervisor Megan Mishou stated that the discipline is generated at the start of the case, but they need to receive updated cases.
  - b. Chief Lisa Kelly stated that she had asked PIB to provide a spreadsheet of what cases have expired.
  - c. Regarding Trial boards, the PAB had selected a civilian to be trained, and they are working 3-4 civilians.
    - i. The mayor appoints the Law Judge
    - ii. MOGR moves the appointments
  - d. Megan Mishou: There is a new folder of 2023 expired cases. Megan did an audit of these cases. There were 17 cases that were never heard. She suggests a special meeting to hear those cases. They can be added to a regular meeting.
  - e. Ms. Mishou stated that the PAB Chair requested a meeting with the PIB. She would like to invite ACC members to that meeting.
  - f. Member Raymond Kelly stated that he will also be addressing a best practices/training and SOPs.
  - g. Reminders: Members David Cramer and Jesmond Riggins will not be in attendance on April 19, 2024.
