- IV. New Complaint(s):

CRB2020-0023--- The Complainant alleged that after the death of her children's father, the Officers, Investigating Officers and PIB involved in this matter engaged in the following: tampering with evidence, withholding pertinent information, falsified police reports changed the cause of death, provided misleading legal advice, and provided no follow-up about the case.

CRB2020-0024--- The Complainant states that an Officer parked in an active loading dock in a tow-away zone. The Complainant, a groundskeeper, informed the Officer of the obstruction, and the Officer refused to move his vehicle. The Complainant called 311 and informed the supervisor of the officer's action. In response, the Officer returned to his vehicle, made rude remarks to the Complainant, and stared him down as he drove off.

CRB2020-0025--- The Complainant alleges that an Officer requested information from the hospital staff about a patient, in violation of HIPPA and without a subpoena. The Officer would not provide his badge or supervisor's information and was confrontational with the hospital staff, threatening to arrest them.

- V. Completed Investigation(s):

CRB2019-0019/PIB2019-0123----- (H, FI): The Complainant alleged that he was pulled over for a traffic stop and was falsely imprisoned because he was detained for one hour. The Complainant also alleged harassment due to his status as a "sovereign citizen." The Complainant's vehicle was towed due to lack of registration plates and was forced to walk home with his belongings and his dog.

CRB 2019-0001/PIB2019-0034--- (H): The Complainant alleged that she was followed into a market by Officers, who instructed the store merchant "not to wait on her." The Complainant was previously seen dancing and singing in the street. Due to the Complainant's inability to cooperate, this case was submitted for administrative closure.

CRB 2019-0192/PIB 20180730----(EF,FA, H): The Complainant alleged he exited his vehicle and was approaching his residence when an Officer in an unmarked car demanded that he return to his car. The Complainant was initially told that he was speeding and then later told his “window was messed up.” The Complainant was subsequently arrested for a stolen vehicle, placed in handcuffs and transported to Central Booking. The Complainant also sustained a back injury during his arrest.

CRB2019-0168/PIB2019-1455---(FI, FA, H): The Complainant alleged that he was approached by three unknown white males who were in an unmarked vehicle with tinted windows and did not identify themselves. He was told he was not under arrest, but was subsequently searched and arrested after the Officers planted drugs and paraphernalia in his vehicle.
