**V. New Complaints:**

**A. CRB2024-0007-PIB 2024-0317:** Filed on March 14, 2024, against an identified BPD officer for excessive force and harassment. The Complainant stated that she has a long history of ongoing harassment by Baltimore City and County police. She believes the harassment began with an incident in 2015 where she was falsely accused of an incident and was later found not guilty. The Complainant has a history with a known Officer who most recently harassed and used excessive force on her in mid-January 2024 at a local store. The Complainant stated that once the Officer identified her, the Officer became aggressive as she was leaving the store and tried to arrest her. During the encounter, the Officer pushed her very roughly using the Officer's bulletproof vest, and pushed her off the curb, causing her body to twist, injuring her ankle and back. The Complainant was able to board a mobility bus to escape. The Complainant now fears going to the location where the incident occurred.

**B. CRB2024-0008-PIB 2024-0410:** Filed on March 23, 2024, against an unknown BPD officer for harassment. The Complainant stated that on February 29, 2024, BPD knocked on his door and asked to interview his 3-year-old son regarding a child abuse case. Child Protective Services (CPS) had called BPD because the son's school advised them that the son had said that the Complainant had struck the son in the head. When BPD arrived at the Complainant's home, they advised the Complainant that they were doing a wellbeing check and gave the Complainant an incident report. BPD left and returned a minute later and stated that they had to take the Complainant's son to the hospital and that the Complainant would not be able to ride with them. BPD advised the Complainant that this was their policy. The Complainant stated that the Officers did not have a car seat, so they waited for one. Another Officer arrived at the home and informed the Complainant the Officers were wrong and that the Complainant could be transported with his son to the hospital. The Complainant feels that he and family were mistreated and mishandled in the situation while waiting in the cold weather.

**C. CRB2024-0013-PIB 2024-0905:** Filed on January 13, 2024, against an identified BPD officer for harassment. The Complainant stated that on January 5, 2024, he was targeted and pulled over by an identified BPD Officer. The Complainant stated that the Officer told him that he was “overtaking a vehicle” which the Complainant denies. The Complainant stated that the Officer argued with him to accept the claims. Out of fear of possibly being harmed, the Complainant was forced to cooperate with the Officer. The Complainant believes that he was targeted by the Officer based on his vehicle and the area he was driving through.

**VI. Completed Cases:**

**A. CRB2023-0120-PIB2023-0799:** Filed on August 30, 2023, against an unknown BPD officer for excessive force. The Complainant stated that on May 9, 2023, her daughter, hereinafter known as “the Victim,” was unjustly placed in a group home where she was pushed down the stairs by an adult and another 14 year old girl. The Complainant was not informed about the incident until the next day when her daughter called and told her that she was in the hospital for the injuries from the incident. The Complainant said that she took her daughter to the local Emergency Pediatric Hospital to report the injuries and a nurse informed her that the police would be called. After the police arrived at the hospital, the Complainant stated that they advised her to leave the property because her daughter was considered a runaway. The Complainant expressed that she pleaded to stay and showed the officers’ videos of her daughter being assaulted in the group home, but the officers was not concerned about the incident. The Complainant is alleging excessive force because her daughter advised her that while in the hospital the police dragged her after she got x-rays and could barely walk with a neck brace. The Complainant also stated that the officers at the hospital threatened to arrest her for bringing her daughter to the hospital for help.
