IV. Director's Report

Mariel Shutinya, CRB Supervisor - In 2022: 36 completed investigations; 30 re3ccodmnetation; 29 cases were closed; 6 cases had sustained allegations; 87 CRB intakes; 237 PIB notifications and 1 was converted to a CRB complaint; received 15 new complainants; 3rd quarter report posted; working on 4th quarter now; still recruiting for new CRB members.

V. New Complaints:

- A. CRB2022-0130: Complaint filed 12/9/22 against named BPD officers for Harassment. The Complainant alleges that he temporarily parked his car in the street with his flashers on for the purpose of unloading his groceries. The Complainant stated that when he finished unloading and returned to his car, two officers had parked behind him, and were there staring at him in a hostile manner. When he asked what the issue was, the officers stated that he should not have parked his car in the street. The Complainant advised that he needed to park closer to unload his groceries due to a recent injury, and there was no traffic on the street. The Complainant stated that the officers then requested his ID and gave him a warning. The Complainant believes that officers treated him this was because he was a Black man in a predominantly white, wealthy area of the City, and that his neighbors had done the same thing many times without incident.

VI. Completed Cases:

- A. **CRB2022-0073/2022-1017**: Disciplinary recommendation for sustained allegation of Harassment.
- Filed 5/31/22 against two named BPD officers for harassment. The Complainant alleges that she called officers to assist with a customer at the restaurant where she worked, because he was upset about a price dispute and was refusing to leave the drive thru area. The

Complainant stated that when the officers arrived, they refused to help her with the situation and instead joined the man in disputing the price. The Complainant stated that one of the officers spoke Spanish but refused to communicate with her in Spanish even though she was having trouble communicating in English. The Complainant stated that the officers also unnecessarily harassed her employee for not having ID while she was working. The Complainant stated that during the interaction, the officers were rude to her and laughed at her.

- Disciplinary Recommendations:
- Tiera Hawkes, Chair, Northeastern Category B in the Disciplinary Matrix, recommendation is 1 day loss of leave and training
 - Mel Currie, Southwestern Simple letter of reprimand
 - Natalie Novak, Secretary, Northern 1 day suspension and simple letter
 - Disciplinary recommendation: 1 day loss of leave and simple letter of reprimand
- B. **CRB2022-0061/PIB2022-0711:** Filed on 4/18/2022 against an identified BPD officer for Harassment. The Complainant alleges that the Complainant previously filed a misconduct complaint against these subject officers. As a result, the officers spoke to his building manager about the Complainant and the building manager told the other residents that the Complainant is a "snitch." On 6/25/2021, there was an incident at the Complainant's apartment building which resulted in the Complainant being taken to the hospital by the subject officers, who made rude and mocking comments about his injuries. Prior to the 6/25/2021 incident, the Complainant made arrangements with one of the subject officers to come into the police station to watch video footage of the Complainant being robbed, and the officer made rude comments to the Complainant during the appointment. The Complainant ended up being evicted as a result of the 6/25/21 incident.
- Mel Currie, Southwestern this was a messy situation, but did not find evidence to show that the officers conspired with the Complainant's building manager against the Complainant; Vote is Not Sustained
- Tiera Hawkes, Chair, Northeastern did not see the nexus between the incident and what the Complainant is alleging; the evidence doesn't meet the burden to sustain the allegations– Vote is Not Sustained
- Natalie Novak, Secretary, Northern not enough corroborating evidence to support the allegations that occurred at the hospital; Vote Not Sustained
