- V. New Complaints:**

- A. CRB2024-0187-PIB2024-1708:** Filed on November 14, 2024, against an identified BPD officer for harassment. The Complainant stated that on November 13, 2024, an identified BPD officer arrived at the Complainant's home with a warrant missing information, illegally searched the Complainant's home, and took photos of the Complainant's children. The Complainant stated that the subject officer is investigating a murder that occurred in front of the Complainant's home. The Complainant stated that she has provided a statement and has given as much information that she is willing to, but she continues to be questioned by the officer. The Complainant alleges that the officer requested to interview the Complainant's children, who are minors, about the murder. The Complainant denied the officer's request stating that the children were not privy to or part of the event that had taken place outside of the home. In response, the Complainant alleges that the officer retaliated by threatening to contact Child Protective Services (CPS) if the Complainant did not allow the children to be interviewed. On November 14, 2024, Child Protective Services arrived at the Complainant's home with allegations that the children were not attending school, the Complainant's son was being abused and that the Complainant did not protect her children from witnessing a murder. The Complainant is alleging harassment because she believes that this was retaliation for not allowing the officer to interview her children.
- B. CRB2024-0014-PIB2024-0906:** Filed on November 17, 2024, against unidentified BPD officers for excessive force on behalf of her niece, the Victim. The Complainant stated that on January 12, 2024, the Victim was standing outside of a store when several officers jumped out at the Victim for no reason. The Victim asked the officers the reasoning for their action. They stated that they wanted to search her. According to the Complainant, the Victim asked the reason for the search, stated that she was a female and urged the officers to not touch her because she hadn't done anything wrong. Further, she was uncomfortable with male officers touching her and wanted a female officer to search her instead. In response, the Complainant alleges that the officers "roughed" the Victim up on the store gates and ignored her plea. The Complainant alleges excessive force

because she believes that there was no reason for the force. Further, the officers should have provided a female officer to search the Victim as requested.

VI. Completed Cases:

A. CRB2024-0013-PIB 2024-0905: Filed on January 13, 2024, against an identified BPD officer for harassment. The Complainant stated that on January 5, 2024, he was targeted and pulled over by an identified BPD Officer. The Complainant stated that the Officer told him that he was “overtaking a vehicle” which the Complainant denies. The Complainant stated that the Officer argued with him to accept the claims. Out of fear of possibly being harmed, the Complainant was forced to cooperate with the Officer. The Complainant believes that he was targeted by the Officer based on his vehicle and the area he was driving through.
