III. Overview of 2021 legislation impacting CRB

- Dayvon Love The bill creates Administrative Charging Committees (reviews PIB investigation and decides if officers will be charged) and Police Accountability Board will hold quarterly meetings with leadership, accepts citizen complaints, and must be representative of the community, PAB nominates certain members of the ACC and Trial Boards
- Yanet Amanuel The scope of allegations enlarges, no limitation any more; ACC decides disciple, Commissioner can go higher, but not lower
- 1) Dissolve the existing the CRB, repeal the 1999 statute and borrow infrastructure from existing CRB to create the statutorily required elements of the PAB's.
- 2) Legislate a carve out for Baltimore city that keeps the CRB structure in place and provides the powers assigned to the PAB's to the CRB (ie.: appointing people to the administrative charging committees).

VI. Discussion of CRB's options in regard to interpreting the legislation

- Dayvon Love 1) dissolve CRB and carry over some CRB functions into the new board; 2) do a carve out that would give PAB and disciplinary authority to the CRB, this one might be more practicable. Legislature is expecting some clean-up legislation for HB 670, so this could be part of it. How do we operationalize the authority of PAB into the CRB structure; so CRB would appoint 2 members of the ACC. Mechanics around investigations and role of ACC and CRB would be something to work out, some reconciliation around that. The CRB has to figure that our. #2 is the most intuitive and least labor intensive option.
- Yanet Amanuel PAB has to issue quarterly reports showing trends in policing
- Dayvon Love Look at intersection of Anton's Law and HB 670 to see how much/what
 information can be made public; CRB should take the lead in deciding how HB670 will be
 reconciled
- Yanet Amanuel CRB has a better way of deciding who is on the PAB, we have a member from each district.
