• Mariel Shutinya, CRB Supervisor: reviewed CRB statistics; upcoming events; OERC is doing more outreach; Civil Rights week is Oct. 31 – Nov 4.

V. New Complaints:

- A. **2022-0142:** Filed on 8/26/2022 against an identified BPD officer for harassment. Complaint alleges that on 7/10/2022 the Complainant called 911 to obtain medical help for their disabled son who was experiencing a mental health incident. Instead of providing medical attention and taking the son to the hospital where the Complainant intended to commit the son, the officer charged the son with second degree assault. The officers did not appropriately address the son's disability and mental health.
- Majority voted for a CRB investigation
- B. **2022-0146:** Filed on 9/1/2022 against BPD officers for harassment, excessive force, and false imprisonment. The complaint alleges that the Complainant "was detained aggressively and unlawfully for possession of a legal firearm. I provided all credentials requested and was not aggressive or noncompliant with officers. After his credentials were verified I was released with no apology or explanation/cause as to why I was detained. I was told that I was detained due to the 'gun violence in Baltimore City'".
- Majority voted for a CRB investigation
