- V. New Complaints:**

- A. CRB2024-0017-PIB2024-1005:** Filed on June 4, 2024, against an identified BPD officer for false imprisonment and harassment. The Complainant filed a complaint stating that on April 18, 2024 an identified Officer unconstitutionally seized his vehicle, currency, bookbag with a laptop and business documents. The Complainant stated that BPD Officers made an unconstitutional stop by pulling him over without probable cause. The Complainant stated that he was charged with a traffic violation. He believes that the remedy to this unconstitutional stop that led to the violation of his 4th Amendment Rights to the Constitution as well as Maryland Law and Declaration of Rights, that all property seized be released, and that all charges be dismissed immediately.
- B. CRB2024-0099-PIB 2024-1251:** Filed on August 22, 2024, against an unknown BPD officer for harassment and abusive language. The Complainant stated that on June 8, 2024, that she was searching for parking on a congested street when a few police vehicles pulled behind her trying to maneuver through the traffic. Fearing that she was in the way, the Complainant moved to the left to allow the Officers to pass through. The Complainant stated that it angered one of the Officers and caused her to be pulled over. Multiple Officers were present which the Complainant felt was overly aggressive and unnecessary. The Officer approached her vehicle aggressive, belligerent and yelled profanity at her. The Complainant became fearful for her life.
- C. CRB2024-01040-PIB Unknown:** Filed on September 11, 2024, against an identified BPD officer for harassment, false imprisonment and excessive force. The Complainant stated that on September 7, 2024, he witnessed a helicopter, a white van and police officers searching for a suspect outside of his home. The Complainant stated that the police and the white van crashed into two cars and the suspects fled the scene. Attempting to move away from the scene, the Complainant turned a corner where four officers were standing and saw him. Instantly, the officers ordered the Complainant to get on the ground. When he fell to the ground, the Complainant stated that he injured his knee. The Complainant was taken to the victim and the suspects to be identified as a

suspect in a carjacking. The Complainant stated that the victim in the incident advised the officers that the Complainant was not a suspect in the crime. By this time, the Complainant said that he had been detained and bleeding with hip and back pain. After the officers found that the Complainant was not a suspect in the incident, he was released and given an incident report. The Complainant stated that he would like to be compensated monetarily and wants his knee to heal properly. In addition, he is seeking medical assistance. The Complainant stated that his primary complaint is police misconduct because he was assaulted, wrongfully accused of a carjacking and his body was injured because of mistaken identity.

**VI. Completed Cases:**

- A. CRB2023-0165-PIB2023-1670:** Filed on November 2, 2023, against identified BPD officers for excessive force, harassment, false imprisonment and abusive language. The Complainant [They/Them] stated that on September 22, 2023, a 12 year old girl, hereinafter known as “the Victim,” was restrained and brutalized by the accused officers. The Complainant stated that they intervened out of immense fear for the child’s life and managed to help the child and her older brother, also a minor, to be safely released. After the incident, the Complainant stated that they attempted to collect information multiple times on all the involved officers from the police department to hold them accountable. However, all the persons the Complainant contacted were uncooperative, leading the Complainant to believe that BPD is attempting to cover up the incident.
